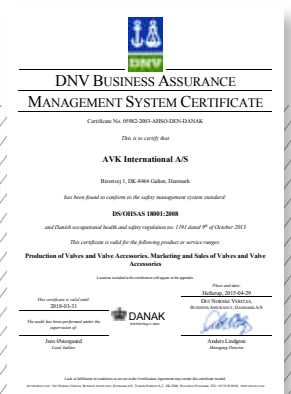
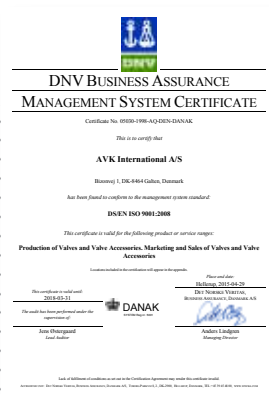
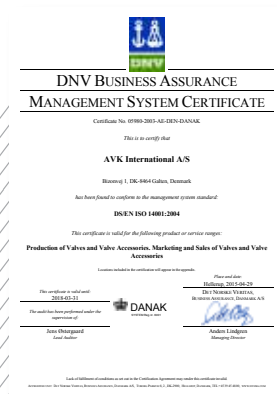
**Sustainable future**
